***** CLUB REGULATIONS *****

Rifle and Pistol Ranges

Are for the specific use of the WFCCC Member, the Members Spouse and children or grandchild under age 18.NO GUESTS Allowed on RANGES at ANYTIME! Only Paper & Cardboard targets can be used on ranges! No Cans, Bottles, Jugs, Balloons, Clay birds or Metal targets of any Kind can be used on Pistol or Rifle Ranges! No Shotguns or Rifles larger than 22cal allowed at Pistol Range. No full auto firearms allowed on either range.

A. General Rules

- 1. New Members are encouraged to attend a meeting soon after joining, to be sworn in. Meetings are the third Wednesday of each month.
- 2. All persons on Club property must have a club membership card in his/her possession or be accompanied by a paidup member who can provide his/her membership card on demand.
- 3. Only a member, his or her spouse, their children and grandchildren under the age of 18 years of age may use Club grounds for Hunting, Fishing, Rifle & Pistol Range shooting, Archery range, and Open field Clay Bird shooting.
- 4. Anyone under age of 18 must be accompanied by an adult member when on any Club property.
- 5. Guests accompanied by members may use Club facilities such as camping, picnicking etc., with the exception of Hunting, Fishing, Rifle, Pistol, and Archery target ranges.
- 6. No trespassing on Club property after 11 pm, unless by prior approval by the board of directors or for the purpose of camping by members or their guests.
- 7. All fires must be put out completely before leaving the Club grounds.
- 8. Grounds will not be littered. Trash will be put in proper containers and grounds kept orderly at all times.
- 9. Any organized activity utilizing large open or enclosed shelters shall be scheduled through Club President
- Intoxicated persons will be denied the use of all Club properties, whether leased or owned. Violations of the rule will
 result in automatic expulsion of all membership privileges.

B. Firearms Rules

- 1. Target shooting will be confined to Club range areas only. Please pick up your trash/brass after you have finished shooting and place it the containers located at each site. Ranges open at 8 am and close ½ hour before Sundown!
- There will be no drinking of alcoholic beverages before or during firing of rifles, shotguns and pistols on the Club ranges.
- 3. Still Target and Trap Shoots: The Shoot Manager shall have the authority to determine when an individual is no longer able to conduct themselves in a safe manner, and shall take corrective action to remove the danger.
- 4. Pistol and Rifle ranges closed at 6 pm during Club Meeting days and 10am-12pm during Easter festivities.

C. Fishing

- Fishing is permitted only to a Member, his or her spouse, their children and grandchildren under the age of 18. No
 fishing license required. Creel Limits: 4 trout per day four trout landed is four trout caught. You cannot give away and
 keep fishing! Use of minnows for bait is prohibited.
- 2. No fish of any kind will be placed in the lake by any individuals. All stocking will be with the approval of the Club.
- 3. Stream fishing on Club property will conform to State Regulations. Creel limit will be the same as for the Lake.
- 4. No boats allowed on the Club Lake.
- 5. No more than (2) poles for each fisherman and must be attended at all times.

D. Hunting

- 1. DWR Regulations apply. Doe Hunting will be allowed on Club owned land and be determined on a year to year basis. ONE Doe per person is allowed for the full deer season. See Club WEB Site for all other Hunting information.
- 2. No wooden/metal tree stands and ladders, manufactured wood, plastic or metal blinds for hunting of any kind are permitted on any Club-Owned or Leased land, must be removed daily.

E. Dogs

 Dogs are not permitted on Club property whether owned or leased by the Club, except while in direct control of member in the pursuit of wild game during normal hunting seasons. Service dogs are permitted as long as they have identifying vest and in control of owner at all times.

The handling of any abuse of the above rules will be governed by the Board of Directors whose action will be final.
